Note: Participants must be at least 16 years old and have a signed waiver from a parent or guardian. Each team needs a minimum of 2 players. Registration is limited to 8 Men's teams, 8 Women's teams, and 10 Mixed teams.

The Superday 2024 Pickleball Tournament will take place if it rains, but will be called off in the event of extreme weather conditions. Given the extensive planning and involvement of numerous staff and playing surfaces, there will be no rescheduled date or refunds.

In consideration of acceptance of my entry into the Superday Pickleball Tournament, I, the undersigned participant, hereby agree and make the following contractual representations and agreements. Further, I will hold the City of Cheyenne harmless from any and all liabilities and provide for the defense of the City in the event the City is sued as a result of my alleged negligence.
