Rules & Regulations

General Play and Tournament Regulations

1. Every player must have a set of golf clubs and bag.
2. Due to the inherent risk in the game of golf, infants and toddlers (under the age of three) are not allowed on the golf courses. Children between the ages of three and eight must be accompanied by a paying adult.
3. Proper etiquette and conduct consistent with the game of golf is required. Shirts & shoes are required at all times.
4. Beverages must be purchased at the course. No coolers or containers allowed.
5. No pets allowed on golf course.
6. The use of conventional metal spikes is prohibited. An approved selection of alternate spikes is available at the Golf Shop.
7. No more than four players per group.
8. Foursomes will be given tee time priority.
9. 18-hole play will be given tee box priority over 9-hole play at the Airport Golf Course.
10. Fishing is prohibited.
11. Golf Carts/Pull Carts
 - a. Private carts are not allowed without the authorization of the Community Recreation and Events Director.
 - b. No one under the age of 19 will be allowed to operate a golf cart.
 - c. Carts must be kept on paths at all times around greens and tees. Otherwise carts must be kept at least 50 feet from all greens.
 - d. Carts directional signs must be followed. Failure to do so may result in the loss of cart privileges.
 - e. Pull Carts must be kept off greens and tees at all times.
12. Green Fee Ticket, Punch Pass or Annual Pass must be produced upon request while on the golf course.
13. Golf course staff will have absolute control of play on the course at all times.
14. No practice allowed on the golf course at any time. A driving range and practice green are available for practice.

General Play and Tournament Regulations - Continued

15. Slow play: Groups will be expected to play nine holes in no more than two hours and fifteen minutes. Groups that are playing slower will be asked to speed up play. Slower groups must let faster groups play through. Groups that fall more than one hole behind will be asked to move to the next hole. Groups that continue to fall behind will lose playing privileges for that day.

16. Tournaments are defined as any individual or group that reserves the golf course or multiple tee times in advance of the day of play. The Community Recreation and Events Department approves all tournament play and reserves the right to deny any group tournament play. Tournaments are reserved on a first come, first serve basis. For more information, please contact the Golf Shop.

Please be advised that failure to follow any of the City of Cheyenne Rules and Regulations will result in the loss of playing privileges for the day. Continued failure may result in loss of privileges for the season.

A Few Words On Maintenance:

Players must be aware of the need to carry out necessary maintenance practices which may interfere temporarily with play.

Practices such as mowing, irrigation, fertilization, aeration, and topdressing are critical in creating the surfaces on which the game is played. For the safety of all, players are required to yield to the maintenance staff at all times, but especially during the early morning hours while the course is being prepared for daily play

Failure to yield to the maintenance staff will result in the loss of playing privileges for that day. Patience and courtesy towards golf course personnel is required and greatly appreciated when maintenance practices are encountered
