Superday 2025 Grass Volleyball Rules

Check-In & Team Requirements

- Teams must check in at the Dunbar Field Supervisor's Table 15 minutes before game time.
- Each team must always have at least two female and two male players on the field.
- The tournament is capped at 16 teams, with all matches played 4v4.
- A minimum of four players is required to start a match. Late arrivals may join after checking in (waiver must be signed).
- Teams may have up to eight players on their roster.

Tournament Format

- Pool Play (June 28, 2025)
 - Each team plays three pool play games.
 - Matches are one set to 25 points (cap at 30). Must win by 2 points.
 - Matches will not exceed 30 minutes. If the time limit is reached, the leading team wins.
 - A 30-minute break follows pool play to finalize the tournament brackets.
- Single-Elimination Tournament
 - Brackets will be posted at the supervisor's table.
 - Matches are best 2 out of 3 sets:
 - First two sets: Played to 21 points (cap at 25).
 - Third set (if needed): Played to 15 points (cap at 20).
 - Must win by 2 points.
 - Matches will not exceed 45 minutes. If the time limit is reached, the leading team wins.

Gameplay Rules

- Game Structure
 - Matches use the rally point system.
 - Each team may touch the ball a maximum of three times before returning it over the net (blocks do not count).
 - Players can move freely on the court after the serve.
 - All present players must rotate in when it is their turn to serve.
- Equipment & Attire
 - Net height: 7'11".
 - No cleats or spikes allowed—only tennis shoes or barefoot.
 - Teams must provide their own uniforms. Attire must be family-friendly. The tournament director has the authority to disqualify players wearing inappropriate clothing.

Sportsmanship & Conduct

- Good sportsmanship is REQUIRED from all players and fans.
- Alcohol is prohibited in the parks and on the field.

Officiating & Scoring

- Teams will referee their own matches.
- Final scores must be reported to the supervisor's table by the team representative after each match.

Game Timing & Forfeits

- All matches start at their predetermined times.
- A 5-minute grace period is allowed before a forfeit is declared.
