The Superday 2026 Pickleball Tournament will be canceled in the event of rain or extreme weather conditions. Due to the extensive planning, staff coordination, and use of playing surfaces, the tournament will not be rescheduled. Refunds will be provided in the event of cancellation.

In consideration of acceptance of my entry into the Superday Pickleball Tournament, I, the undersigned participant, hereby agree and make the following contractual representations and agreements.
